



Lime Down Solar Park Consultation feedback form

Island Green Power (IGP) is bringing forward proposals to build a new solar park and battery energy storage project on land in North Wiltshire.

Lime Down Solar Park has the potential to generate around 500 megawatts (MW) of electricity. This is equivalent to providing enough clean energy to power around 115,000 homes.
